Hospices are not included in calculation of state or national averages for a measure if there were fewer than 11 respondents for the measure. State-level variation in CAHPS Hospice Survey scores should be interpreted with caution given the variation across states in the proportion of hospices for which CAHPS Hospice Survey data are reportable.
